Mesa Union will require students to hand wash and/or hand sanitizer frequently throughout the day including: • Upon arrival to the classroom • Before and after recesses and lunch • Before and after using the bathroom • As needed throughout the day To support healthy hygiene, Mesa Union will provide hand sanitizer dispensers for all classrooms, restrooms, and office spaces, including the main and district offices. Mesa Union will provide additional standing hand sanitizing stations for placement outdoors and at entry ways, as needed. Mesa Union will ensure that faucets in staff/students restrooms and classrooms are in working order and have access to paper towel dispensers. Mesa Union will provide face coverings for students, and will provide both face shields and masks for staff members. Face coverings will be required for students, staff, and visitors according to CDPH Guidance School and School-Based Programs. Playground equipment will be disinfected between use. Mesa Union has developed and implemented COVID Cleaning Procedures, which will be revisited and kept current on a regular basis. Only cleaning products approved for use against COVID-19 on the Centers for Disease Control (CDC) approved list will be used for cleaning and sanitizing. Staff will be trained by health and safety personnel on the proper and safe usage of disinfectants, and will complete online training modulse on Cleaning and Disinfecting your Workplace (practical guidance from the CDC for cleaning and disinfecting classrooms and areas). Mesa Union will provide disposable gloves appropriate for all cleaning and disinfecting to staff, as well.

High touch areas including door handles, sink handles, light switches, and desks will be sanitized at least once a day (beginning of day or end of day) by custodial staff. Custodial staff will clean the restrooms several times a day including after the start of school, between all recess and lunch

There will be 7 campus entry points (6 in the front and one on the middle school side); students will need to remain physically distanced while waiting to enter campus. Before entering campus, all students will wash their hands or sanitize. A staff member will take their temperature with a no-touch thermometer. Any student with a temperature over 99.5 will need to wait in a waiting room for pick up.

Routes will be created and followed to reduce exposure. Everyone will use walking paths with direction markers around the school to limit the number of people in the same area.

Plexiglass partitions have been added to the front office, and visitors can only enter through the front door, one person at a time. Each person entering will be asked to hand sanitize, have their temperature taken, and follow symptom screening questions.

Campus access for volunteers will be very limited to scheduled sign-up times in order to avoid overlap in the workroom and classrooms. Students, staff, and volunteers will wear face coverings on campus. Mesa Union has several options for using outdoor spaces for educational purposes:

- 1) Mesa Union has access to bench areas next to the middle school classrooms and next to the MPR. This will allow teachers and specialists to bring a class/group(s) outside for instruction.
- 2) Teachers/Students will carry chairs to outdoor locations with 6 foot distancing. They will use lapdesks/whiteboards to enable them to work.
- 3) Mesa Union is purchasing additional shade pop-up canopies to create additional outdoor spaces available.

Limit Sharing

Mesa Union will limit shared supplies and equipment. Each student will sit at their own individual desk, 6 feet apart, facing forward in the classroom. Students will not share technological devices; each student will be assigned their own laptop or iPad. During recess the playground structures will not be used. Playground equipment will be disinfected between use. Students will not share lunch or snack items at any time.

Mesa Union employees will be oriented and trained COVID-19 specific symptom identification, physical distancing guidelines and their importance, use of face coverings, screening practices, prevention measures, and transmission of the illness during staff development sessions. Mesa Union staff will also complete SafeSchools online training modules for Coronavirus Awareness (identify symptoms, risk factors and ways to reduces chances of being infected), CDC Guidelines for Using Cloth Face Coverings (best practices for wearing face coverings), and Cleaning and Disinfecting your Workplace (practical guidance from the CDC for cleaning and disinfecting classrooms and areas).

Mesa Union staff will be trained on cleaning and disinfecting,use of personal protective equipment (PPE), first aid, surveillance of attendance (reporting, case management, and re-entry); contact tracing introduction for district liaisons; and HIPAA-FERPA. These trainings will be provided by health and safety personnel during staff development sessions and by VCPH.

Parents/families will be educated on COVID-19 through instructional videos, parent meetings, the Mesa Union Reopening website, flyers, and on-campus posters. Mesa Union will begin communicating re-entry procedures to families as soon as on-site learning is feasible. Parents and students will sign a document acknowledging the expectations with the understanding of consequences for failure to comply. Messaging and videos will be developed for topics including

- Proper use of face coverings
- Proper hand washing methods (Scrub with soap for at least 20 seconds or use hand sanitizer if soap and water are not accessible. Use paper towels to dry hands thoroughly. Wash hands when: arriving and leaving home; arriving at and leaving school; after playing outside; after having close contact with others; after using shared surfaces or tools; before and after using restroom; after blowing nose, coughing, and sneezing; and before and after eating and preparing foods.)
