IPM statement

It is the goal of Mesa Union School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

Focus on long-term pest control, prevention and mitigation. Mesa Union uses pesticides at a minimum, if at all. Mesa Union also relies on contracted services through a pest management contract with AIPM (Animal & Insect Pest Management) for the same.

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: IPM Coordinator, Facilities Workers, Pest Management Contractor
(Example: College/University staff, Pest Control Business, etc.)

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Maintenance and Facilities Workers and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

Mesa Union staff regularly undertakes facility staff walkthroughs of the school grounds, rooms and monitoring any discovery of pest activity during their daily routines. Mesa Union has also established a ticket system for reporting details of any possible pest issues. Custodial staff is also responsible for proactively cleaning all common areas, including classrooms, walkways, dining areas, kitchen and cafeteria, which serve to diminish likelihood of pest infestation.

Chemical pest management practices

Submittal of pesticide use reports

- Reports of all pesticides applied by school district staff during the calendar year, except pesticides exempt¹ from HSA recordkeeping, are submitted to the Department of Pesticide Regulation at least annually, by January 30 of the following year, using the form provided at www.cdpr.ca.gov/schoolipm. (Education Code Section 16711)
